WHEREAS, the Annual Budget for the Englishtown Borough Fire District No. 1 (the "Fire District") for the fiscal year beginning January 1, 2015 and ending December 31, 2015 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 4, 2014; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$540,514, which includes an amount to be raised by taxation of \$460,000, and Total Appropriations of \$540,514; and


WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. 

WHEREAS, the adopted budget is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and



2015 BUDGET MESSAGE AND ANALYSIS**

#1- Administration Salary and Wages increase due to reclassification of Uniform Fire Safety Act expenses so that Appropriations would equal Anticipated Revenues. Maintenance and Repairs increase due projected expenses being higher than 2014. Appropriations offset with Revenue Fringe Benefits projected to increase. Interest on Debt decrease due to less principal outstanding.

#2-District is utilizing \$66,070 of available surplus to limit tax increase. The utilization of surplus should not have a negative effect on future budgets.

#3-District is in compliance with tax levy cap by utilizing prior year cap bank.
