

The Board of Fire Commissioners Fire District # 1 Borough of Englishtown, State of New Jersey, convened on Tuesday January 7th, 2020 in the Formal Meeting Room of the Englishtown Fire Department, 3 South Main St. Englishtown, New Jersey.

The meeting was called to order by Chairman Peter Cooke at 7:10 P.M.

1. **Sunshine Statement by Attorney J. Youssouf**

Legal: A Hearing of the Budget for 2020 was opened. A motion to open the Public Hearing of the 2020 proposed budget was made by P. Cooke and a second by V. Sarti. Motion passed unanimously.

The Board Accountant stated that there was no increase or impact to the taxes and that there may even be a slight decrease. There was no additional public comment on the proposed 2020 budget.

A motion to close the 2020 Budget Hearing was made by V. Sarti and a second by P. Cooke. Motion passed unanimously.

A Resolution to adopt the Proposed 2020 Budget was made. A motion to accept the resolution was made by P. Cooke and a second was made by B. Stonaker. Motion passed unanimously.

A Resolution to adopt a temporary operating budget for 2020, which will be 14% of the 2019 Budget, to be used for any expenses that may occur from January 1st, 2020 to the March 2020 Organization Meeting. A motion to accept the resolution was made by P. Cooke and a second by B. Stonaker. Motion passed unanimously.

Nomination Petitions for the 2020 elections were offered. There are two positions for full three-year terms and one position for the unexpired term. All petitions must be in by January 20th, 2020. The Board Clerk will notify the Board Attorney no later than January 21st, 2020 if any other Nominating Petitions are turned in by the deadline.

December 2019 Minutes: A motion was made by P. Cooke and a Second was made by V. Sarti to accept the minutes. Motion passed by unanimous vote.

December 2019 Financial: A motion was made by P. Cooke and a Second was made by B. Stonaker to accept the Bills. Motion passed by unanimous vote.

Auditor/Accountant: Working on the W-2s and end of the year paperwork.

P. Cooke requested that the Fire Department only report Fire Calls and not EMS Calls in 2020 as the District is not responsible for EMS Calls. A memo will be sent to the Chief as to how P. Cooke wants the breakdown of the reports to be for 2020.

The Chief and Captain met with E.M. Labs to look at new Four Gas meters. Upon inspection of our old meters, the vendor stated that the meters we have are repairable and are better than the ones he brought. Total cost for repairs was \$1,200.00.

The Chief's Fire Helmet was expired as per NFPA standards, so he ordered a new one from the Firestore to replace the old one. The cost was \$625.00

The Board unanimously approved both requests.

P. Cooke stated that in 2020 purchase requests will be a separate category on the meeting agenda.





CHIEF'S ANNUAL REPORT 2020

The Englishtown Fire Department responded to a total of 372 (414) calls for service for the year 2019, for a total of 928.59 (1268.08) Staff Hours. Of the 372 total calls, 134 calls were not answered (36%), 51 calls were answered short staffed (14%) and 187 calls were answered with a full staff (50%). Of the 93 calls in Englishtown Borough, 30 calls were not answered (32%), 20 calls were answered short staffed (22%) and 43 calls were answered with a full staff (46%).

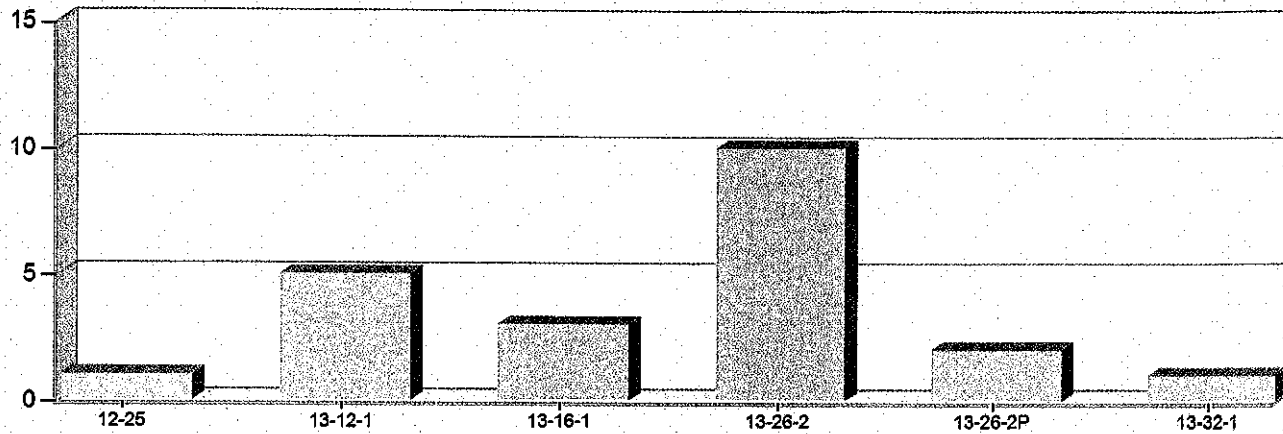

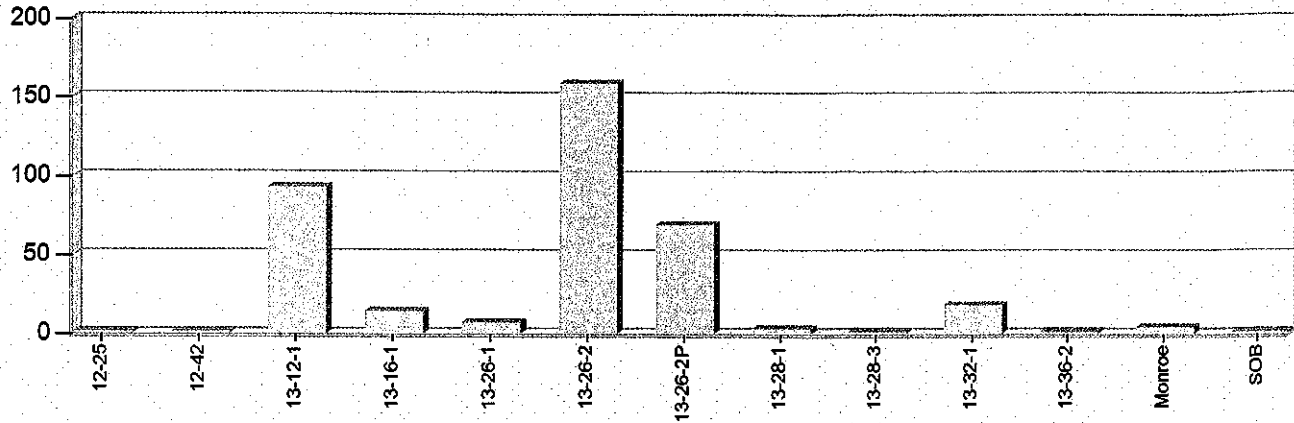
