WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$893,803.71 which includes amount to be raised by taxation of \$599,396.92, and Total Appropriations of \$893,803.71; and

WHEREAS, an election shall be held annually on the third Saturday of February in each established fire district to determine the amount to be raised by taxation for the ensuing year;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District at an open public meeting held on Jan. 26, 2025 that the Annual Budget of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby adopted and, shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$893,803.71, which includes amount to be raised by taxation of \$599,396.92, and Total Appropriations of \$893,803.71; and

The 2026 budget is \$97,053.71 higher than the 2025 budget. This is due to increases in professional services of \$2,000, insurance expense of \$10,000, Other admin expenses of \$3,000. Amount raised by taxation is expected to increase by \$30,960, with the tax rate increasing from \$0.138 to \$0.144. Fire fighting equipment decreased \$20,000. There is a new Chiefs Response Vehicle for \$90,000 introduced in 2026 as well.

Fire fighting equipment to decrease due to larger purchases needed in CY for replacing old equipment. Membership and dues decreasing due to over budgeting in PY, Training to decrease due to less sessions offering in 2026, Utilities to decrease. Contracted Volunteer Fire Co. to increase due to increase in rates. UFSA expenses to increase based on expected increase in activity. Professional services increased due to expected increase in legal fees with a new lawyer, and relocatin of bookkeeper compensation to this line item. Unrestricted fund balance was reduced by \$23,907 due to less funds required to offset the amount to be raised by taxation for the 2026 budget. Restricted fund balance was increased by \$90,000 due to capital purchase of a new Chief's vehicle. Administration personnel S & W decreased by \$31,000 by redesignating Bookkeeper compensation to Professional Services line. Appropriations offset with revenue – personnel increased to reflect the compensation of Fire Official and Fire Inspector. Total Capital Appropriations decreased by \$50,000 due to a decrease in appropriations for future capital line item.
