The 2025 budget is 114,253.00 higher than the 2024 budget. This is due to a purchase of a fire apparatus truck for a down Payment of \$ 100,000.00. The tax rate is expected to go from \$ 0.149 to \$ 0.156

The increase is due to a reduction in debt. 33,247.00 which was the final payment in 2024 on our radio lease purchase. Fringe Benefits increased by 500.00 due to increased costs. Professional services increased by 4,000.00 due to a change in professionals and Maintenance and Repairs-Building increased by 5,000.00 due to increased costs. Length of Service Awards increase by 7,000.00 due to increased costs. Computer Equipment and Supplies increased by 3,000.00. Membership and Dues increased by 8,000.00. Fire Fighting Equipment increased by 20,000.00. Capital expenditures increased by 100,000.00 due to the lease purchase of a Spartan Fire Engine. Insurance Costs increased by 10,000.00
