- The Training Committee has scheduled a walk-through of the Verizon Building on Harrison Avenue for August 4th. 26-2 has been invited.
- The Training Committee is looking into pricing on a train-the-trainer class for the bailout systems.

Building

- Fernandes will be installing hose bibs in the bays once the scissor lift gets delivered. We will try and repair the damaged airline fitting in the front middle bay and replace HVAC filters while the lift is here.
- One of the HVAC Air Handlers in the Utility Room has been leaking water onto the Gear Dryer. For now, the breaker has been turned off to the gear dryer, and a tarp has been placed over it to prevent water damage. In the future, I would like to get estimates to put in a plexiglass cover to divert the water away from the dryer should another leak occur. The district engineer may elaborate further on the HVAC repair.

- I met with Don Ruprecht from J.A. Montgomery Consulting who works for the 1st Responder I/P for our annual safety review. Don did a walkthrough of the station, and we reviewed SOGs and department operations. He will send a report on his visit and recommendations when prepared. It went well.

- Need to investigate getting the Fax Line or service repaired. We used to use Nextiva which is a VoIP based fax service. Our doctor's office will not send results via email due to HIPAA laws.
